March Minutes

PLAG Minutes

March 10, 2018

Officers of the Board in Attendance: Marcie Edwards, Linda Roberts, Bonnie Sands, Jim Sawatzki
Absence excused: Carolyn Stolz. There were 11 additional members in attendance

Welcome:

President, Jim Sawatzki, called the meeting to order at 9:30 and thanked Patricia Schmidt for bringing refreshments.

Sunshine Committee chairperson, John DeFrancesco, announced that donations given to PLAG in memory of Charles Marshall were arriving by mail and, as requested, will be designated for the PLAG scholarship fund. John offered to write personalized thank-you notes to donors of behalf of PLAG.

John made a formal motion that funds being donated in memory of Charles Marshall be directed to the Scholarship Fund. Motion seconded by Sue Arnold and carried unanimously.

Treasurer's Report:

Due to Carolyn Stolz' absence, there was no Treasurer's Report presented.

Susie Arnold made a motion, seconded by Marci Edwards, that \$1,000 from the 2017 Craft Show be directed to the Scholarship Fund for 2018. Motion carried.

Minutes:

Sue Arnold noted that as the Gallery Committee does not make decisions regarding budget, that the following changes be so reflected in the minutes:

Suggestions were made that the Gallery Committee consider making recommendations for:

(Under *Investments*)

A motion was made by Claudia and seconded by Jim that the Gallery Committee review these final proposals [**be reviewed by the officers of the Board**] and invest \$10,000 in a growth fund, and \$10,000 in a CD.

A motion was made by Patricia Schmidt and seconded by Marcie Edwards that the minutes be accepted as corrected. Motion carried.

Gallery Committee:

Sue Arnold suggested that the remaining balance of the \$1,600 donation made in memory of Lou Marshall (in support of the arts and PLAG artists) be used for prize money for the June show.

Following discussion involving other possible uses for these funds, a motion was made by John DeFrancesco and seconded by Donna Arndt that the issue be tabled. Motion carried.

The Gallery Committee will be soliciting sponsors for the June show. Sponsor donations will go to the scholarship fund. Recognition for sponsors will be in the form of a certificate.

Sue distributed entry forms for the June show. Deadline is May 19th.

Announcements:

Jim announced that the outreach drawing classes at the library were going well and asked for a volunteer to fill one empty slot as instructor. (April 19)

Marci Edwards gave an additional dues reminder and announced that she would be updating the membership list.

Patti Schmidt gave a reminder that the silent auction of the PLAG artifacts is underway "For PLAG Members Only" until the end of April. After that, all items will be for public sale.

A motion to adjourn the meeting at 10:30 was made by Marci Edwards and seconded by Bruni Berkowitz. Motion carried.
