

- Jim expressed concern that the number of participants in the Monument Library Drawing classes is decreasing. He asked members to make suggestions for other community outreach opportunities.

Gallery Committee Report:

- Susie Arnold announced that the opening for the Color Splash show went well. At least four pieces of art have already been sold.
- There was a short discussion about the concern for the microphone system at TLCA. It was difficult to get the attention of visitors and to hear some of the speakers as they announced awards.
- In like manner, several members expressed dismay that Mr. Woods, (husband of the late Judy Woods in whose honor that show was presented) could not be heard. As he also made an additional financial donation to PLAG, a thank you note will be sent to him by Carolyn Stolz.
